The property is situated on the north side of the pedestrianized section of Abington Street, adjacent to the entrance into The Grosvenor Centre. Other occupiers close by include H&M, Clarks, Costa, Virgin Media, JD Sports, Carphone Warehouse, River Island, Waterstones, Holland & Barrett, Topman / Topshop, Superdrug, Waterstones and Primark. Metro Bank are due to open 29 Abington Street in Summer 2018.

Description

The property is arranged on ground, first and second floors to provide a former department store. The property comprises two large floor plates on the ground and first floors, both of which levels have **direct access into the Grosvenor Centre** which has a footfall of over 11,000 visitors per year. The second floor comprises ancillary accommodation and loading access.




Floor Plans
